## RESOLUTION

The 1st May 1995

SUBJECT—Recommendations of the Orissa State Commission for Backward Classes— Inclusion in the list of Socially and Educationally Blackward Classes.

The Orissa State Commission for Backward Classes after examining the requests for inclusion of certain Castes/Communities have advised in the State Government on the 19th December 1994 and 20th December 1994 for inclusion of 'Kurmi' (କୁମି), 'Kuruma Chasa' (କୁମ୍ମ ରହା ), 'Kudumi' (କୁନ୍ଦିମ), 'Kurma' (କୁମି), 'Kurmi Mahto' (କୁମିନ୍ଦିନ୍ଦି), 'Kurmi Khetriya' (କୁମିନ୍ଦିନ୍ଦି), 'Kurumi' (କୁନ୍ଦିନ୍ଦି), 'Kudumi Kshyatriya' (କୁନ୍ଦିନ୍ଦି) and 'Bhanja Puran' (ବ୍ୟକ୍ ପ୍ରଶ୍ର) in the list of Socially and Educationally Backward Classes. Government after careful examination of the recommendations of the Commission have been pleased to accept the advice of the Commission. Accordingly Castes/Communities 'Kurumi' ( জুর ), 'Kuruma Chasa' (জুরুর ভ্রম), 'Kudumi' (জুরুর), 'Kurma' (জুরুর), 'Kurmi' (জুরুর), 'Kurmi' (জুরুর), 'Kurmi' (জুরুর), 'Kudumi Kshyatriya' (জুরুর জুরুর) shall be included in the list of Socially and Educationally Blackward Classes and placed at Sl. No. 182 and 'Bhanja Puran' at Sl. No. 183 of the list of S. E. B. C. notified in Annexure 'A' of erstwhile Tribal Welfare Department Resolution No. 25455-TW., dated the 10th September 1993 published in the Orissa Gazette No. 40 (Supplement dated the 1st October 1993.

ORDER-Ordered that the Resolution be published in the xtraordinary issue of the Orissa Gazette and copies thereof be sent to all Departments of Government/all Heads of Departments/all Collectors and all other Offices of the State Government.
